1. The meeting was called to order at 2:03 PM
2. Roll call: present Nanette Mone, Peggy White, Darryl Darby and Ed Fahey.
3. Private well regulation discussion continued. The new state guidelines were reviewed and compared to the draft regulations that the board has been working on. Ed advised and the board agreed to take more time to read the new guidelines with a view to what pertains to Peru.
4. Peggy advised that the board needed to make a formal vote on the mini grant requested purchases. A motion was made to approve the expenditure requests of the mini grant funds for the following items: updated CPA mannequins to train fire department and town employees and interested town residents, first aid kit and fillers, tick removal devices, baby changing table for the community room as an emergency shelter, public notice cost for the public hearing on private well regulations and a new stand up announcement board. All were in favor. Darryl will send in the necessary forms to Jaymie.
5. Peggy stated that the board needed to turn in a budget for the coming fiscal year. After reviewing upcoming items, the board arrived at the figure of \$1,000.00 that Darryl would be presenting to the finance committee meeting later this day.
6. Also an account for the mini grant funds has to be set up. There is already an account for the rural health equity funds.
7. The next meeting has already been set up for April 17, 2023; the agenda has been posted too.
8. A motion was made to adjourn at 4:04 PM. All in favor.
