Item 6: Update of Departments

Highway - Justin Russell, Superintendent reporting

Highway Superintendent Russell reports the following; Parts for Mowers received. Reports chainsaw accident to Highway worker Eric Cofton, who was transported to BMC Emergency Room. He was cleared to return to work. Cullett suggests written warning due to not wearing proper safety clothing while using chainsaw.

Chair Munch reporting: Discussion of list of things to be accomplished; Installment of LED electronic sign.

Jim Kenney, Cemetery Commission: Provided Zoom instructions; Discussion of drone photos of each cemetery; Discussion of process of head stone cleaning; Munch asked if we have list of people buried? Kenney asked about Cemetery Trust Fund. Leach stated that Town Accountant has Trust Fund document. Discussion of printing Historical Book for 250th Anniversary celebration. This would be a reprinting of the book for the 200th Anniversary. Kenney stated there may be some mistakes in the book, and they will print notes to make corrections. Discussion and showing of commemorative medallion to get input from Select Board.

Town Administrator reporting: Update on Police Chief resumes; Confirmation of COVID-19 Funding.

Officer in Charge Cullett reporting: Reported the removal of two signs on South Road Extension posted by Garnet Lake Association. The roadway is not a private way.
