#### SELECT BOARD MEETING MINUTES: May 2, 2023 @ 6:00 P.M.

Item 1: Call to order: Selectman Cullett called to order 6:00 P.M.

Item 2: Roll Call: Selectman Cullett present, Selectman Haskins present, Chairman Leach absent

Item 3: State Recording status: None

Item 4: Pledge of Allegiance to the Flag: Led by Selectman Cullett

#### Item 5: Review and Approve BOS Meeting Minutes for 04/18/2023:

Selectman Cullett motion to table 4/18/2023 minutes, Selectman Haskins second, 2-0

#### Item 6: Updates of Departments

Highway Superintendent Russell mentioned that the Ford 550 is back from Marcotte, the engine was reprogrammed, and the check engine light is back on. Also, the Ford 350 has issues, but Superintendent Russell will put repairs on hold because he doesn't have the funds available. Highway Superintendent Russell submitted the invoice from Tonlino to TA Walker for payment. The payment for Tonlino will be paid from the Mohawk Trails Grant for material on Pierce Road. Crack sealing was scheduled for this week, but Superintendent Russell rescheduled until the last week of May. Bridge inspections were completed by MassDot on Middlefield Road and East Windsor Road with some concern on both bridges. Superintendent Russell plans to apply for a Small Bridge Grant, since both bridges meet the requirements at a later date. The tree issue on a private road has been handled by Mr. Richardson. The Town was not responsible for removing the tree on a private road.

#### Item 7: Discussion and possible vote on repair for the Peru Fire Engine:

Fire Chief Pelkey mentioned that he emailed the Selectboard notifying them that the Tanker is down because the alternator is cracked and not charging. Chief Pelkey feels that because this is an unforeseen expense that he will be submitting a Reserve Fund transfer for \$2,500 for an alternator and electronic board. Chief Pelkey stated that the repairs are an emergency because the Tanker is back up to the Fire Engine. Plus, Hilltown stated that the electronic panel was fried. Selectman Cullett agreed that Chief Pelkey should fill out a Reserve Fund Transfer and submit to the Finance Committee.

Chief Pelkey mentioned that the Fire Engine is back from Freightliner in Westfield, MA. The parking brake is not holding at 1,000 RPM, the brakes are still not working properly and have the same issue as before they were repaired. There is a possibility that the axel needs to be replaced so the brakes will work properly. Chief Pelkey mentioned that in order to pass Mass Inspection the brakes must hold at 1,000 RPM. Freightliner felt the Fire Engine should be brought to American LaFrance. Fire Chief Pelkey reiterated once more that American LaFrance has been out of business since 2015. Chief Pelkey found a place in Louisiana that would modify the rear axle for \$30K-\$40K. Selectman Haskins asked why he

bought the Fire Engine in the first place. Chief Pelkey stated that he did not look at the truck and other firefighters would not allow him to go with them to inspect the fire engine before it was purchased. Selectman Cullett mentioned that at the time of purchase the fire engine had low miles, low hours, was in good shape and a good fit for the town. Selectman Cullett felt that this is still a good truck, but it is hard to find parts. Chief Pelkey mentioned that there are other issues that Freightliner mentioned. Selectman Haskins stated that none of the minor issues will fail inspection except the brakes. Heather Brooks felt that everyone should stay focused on finding a solution to get the fire engine back on the road. The Selectman gave Chief Pelkey permission to call Zwack in New York and ask for a quote to replace the rear axle. Selectman Haskins made it clear that Chief Pelkey should not purchase new tires before he gets the brakes fixed.

Fire Chief Pelkey mentioned that the Board of Health grant has been received. He distributed medical bags to the town hall, library, fire house and highway department. Also, the mannequins have arrived and several towns people are interested in CPR classes.

Item 8: Interview Susan Koziara for the Assessor position: Interview. Susan Koziara was interviewed for the Assessor position. Ms. Koziara lives in Lanesborough, MA and has been an appointed Assessor in Dalton for ten years and an elected Assessor in Lanesborough, MA for 24 years. After losing an election by 50 votes, Ms. Koziara taught school from 2007-2017. Ms. Koziara is interested in working in Peru and misses working with people and explaining the assessing process. She has worked with Patriots Properties software and is familiar with Cartographics mapping system. Selectman Cullett explained that the bulk of the work is outsourced to Patriots Properties. The Board of Selectman needs to go to Annual Town Meeting to change number of Assessors from a 3-member board to a 1-member board. Selectman Cullett explained that the salary is not an hourly position and the town needs people with Ms. Koziara's skills. Assessor Amy Davidson was present, and she has been completing more work than she anticipated. The contract will be reviewed to see if Patriots should be completing all abatements, exemptions, chapter land and liens. The Board of Selectmen will review the contract to be sure Patriots is doing all the work in the contract. The position requires Monday evenings from 6:00 p.m.- 8:00 p.m. and very flexible hours. Assessor Amy Davidson mentioned that she works about 40 hours per month, and she stated that she wished the Assessors would have been part of the RFP for Patriots. Selectman Cullett mentioned that the salary depends on whether the Assessors have a 3-member board or a 1-member board. The stipend for a 3-member board is \$3,500.00 per year.
