### SELECT BOARD MEETING MINUTES: March 20, 2023 @ 6:00 P.M.

Item 1: Call to order: 6:00 P.M.

Item 2: Roll Call: Chairman Leach present, Selectman Cullett present, Selectman Haskins joined meeting at 7:33 p.m.

Item 3: State Recording status: Selectman Leach for personal reasons under Exemption E

Item 4: Pledge of Allegiance to the Flag: Led by Selectman Leach

#### Item 5: Review and Approve BOS Meeting Minutes for 03/13/2023:

Selectman Leach motion to approve 03/13/2023 minutes pending changes, Selectman Cullett second, 2-0,

Item 6: <u>Updates of Departments</u>: Highway Superintendent Russell asked permission to extend the loader rental for another month. The rental is \$3,900 per month and the reason is the large amount of snow that must be moved as well as Spring Road repairs. Selectman Leach felt that the highway department needs the loader to move snow from the last major storm and he is in favor of extending the rental for another month. Superintendent Russell mentioned that the anticipated date of the new loader may be as early as June or July. Selectman Leach motion to extend rental of loader, Selectman Cullett also in favor of extending rental of loader. 2-0. Superintendent Russell also mentioned that Fuel Account may go over budget. Selectman Cullett suggested going to the Finance Committee with the Fuel Account because this is an unforeseen expense due to the amount of snow plowing this winter.

Fire Chief Pelkey mentioned that a portion of the Board of Health Grant (Covid Relief) will be used to purchase mannequins for the Fire Department. The Board of Health Grant will also be used for medical bags for highway trucks, town hall and community center. The Board of Health Grant will also purchase baby changing tables at the town hall (emergency shelter) and one changing table for the fire station.

Fire Chief Pelkey mentioned that Pittsfield Pipers installed the new furnace at the fire house, and it is up and running. Fire Chief Pelkey also mentioned he was awarded a Senior Grant for \$1,777.00 and the funds were be electronically deposited on March 9, 2023 in one of Peru's bank accounts. Selectman Leach asked Chief Pelkey to check with the Town Treasurer to be certain the funds were deposited before he starts spending the money. Chief Pelkey plans on purchasing batteries, lockboxes, smoke detectors, CO detectors and anything Senior related. Selectman Leach mentioned that if the grant money has been received that Fire Chief Pelkey can use the town credit card to purchase items. Chief Pelkey asked permission to purchase garage door opener remotes for the fire department on Amazon. The price at Amazon is \$20.00 versus \$50.00 at Overhead Doors. The Selectboard did not have a problem with Chief Pelkey using Amazon for purchasing garage door opener remotes.

James Kenney, Cemetery member mentioned that he is down to a 3-member board and the board is a 5-member board. The Cemetery Commission cannot meet because they need a quorum and only two members are available. Selectman leach mentioned that one member of the Selectboard may step in to fill the position on a temporary basis until the vacancies are filled.

Amy Davidson, Assessor, mentioned that the Division of Local Services finally accepted the \$10,000 personal property exception that was voted at Annual Town Meeting in 2005. Former Town Clerk, Candice Cahalan, signed the paperwork in 2015 but did not submit to Boston. The \$10,000 personal property exemption was not legal until it was filed in Boston. Amy would like to thank Terry Walker, Administrative Assistant for helping her finalize the paperwork and with the submission that should have been submitted in 2005.

Ms. Davidson received an email from Ross Vivori, Principal Assessor in Great Barrington. Mr. Vivori mentioned that he would be willing to step in immediately and assist. Ms. Davidson mentioned that Mr. Vivori spoke with Duane from Mayflower and if Patriots is not doing everything in the contract, then the town has reason to terminate the contract with Patriots. At that point, Duane from Mayflower and Ross Vivori would be willing to step in immediately and take over in Peru. Selectman Leach asked Ms. Davidson what she wanted the Board of Selectmen to do. Selectman Cullett mentioned that they need a reason to break the contract. Ms. Davidson said TA Welch did not give her a copy of the contract and requested a copy of the contract to review.

Selectman Leach received an estimate from Jay Jewell to secure the town offices with partitions and doors.

Item 7: <u>Discussion and possible vote to Appoint James Kenney to Conservation Commission</u>: The Board of Selectman received a letter of interest from James Kenney for one of the open positions on Conversation Commission. Selectman Cullett motion to appoint James Kenney to the Conversation Commission, Selectman Leach second, unanimous vote 2-0

## Item 8: Discussion and interview Robert Ireland for the position of Town Administrator:

Robert Ireland resides in Pittsfield, MA and interviewed for the Town Administrator in Peru. Mr. Ireland's objective is "To earn a challenging position, where his education and experience will contribute to growth of the organization and create positive change through innovative thought, planning and collaboration." He feels that after reviewing the qualifications for the TA position, the qualifications fit closely with his continued professional experience.

Mr. Ireland is very interested in the position as Town Administrator. He claims he can devote 25-30 hours per week and make it work. He has taught school, is fluent in Ukrainian, he was the director of the Lenox Library and responsible for raising \$300,000 for the library with a staff of 3 employees. He has assisted with grant writing and procurement consulting with Fiber Connect and high-speed internet. Mr. Ireland has some knowledge of Open Meeting Law and has acquired Cultural Council grants plus Covid grant funding for the Lenox Library during the pandemic. He would like to see Broadband in Peru to bring high speed internet to our isolated town. Selectman Cullett asked is Mr. Ireland had experience with Procurement Laws. Mr. Ireland mentioned he did not have much, but he was a quick learner and had some experience with the Peace Corps. Mr. Ireland mentioned if he is hired, he will be passionate about finding money for Peru. His goal is to help Peru prosper and work on making the town more attractive for people to reside in Peru. He feels he is a level planner with everyone working together although he mentioned he is not heavy handed. Mr. Ireland believes things are accomplished by helping people and he likes to lead by example. If hired, Mr. Ireland plans to help all boards and steer them in with right direction with guidance. Selectman Leach asked if Mr. Ireland had ever attended an Annual Town Meeting, Mr. Ireland mentioned that he had attended a virtual ATM in Lenox. Selectman Leach asked Mr. Ireland where he see himself in 5 years. Mr. Ireland stated that he would like to be in Peru as long as possible gaining experience in Municipal government but a 5-year span as a Town Administrator in Peru is his goal. Selectman Cullett mentioned that Mr. Ireland is the first person that was interviewed and is unsure when he will be notified. Selectman Leach asked if Mr. Ireland would accept emails on weekends and when he was on his days off. Mr. Ireland said he would answer emails within reason. Selectman Leach thanked Mr. Ireland and mentioned that he would be notified either way.

<u>Item 9: Discussion and possible vote on Deadline date for Petitions to be put on the ATM Warrant:</u> Selectman Leach motion to set deadline date as April 10, 2023 for petitions to be placed on Annual Town Meeting Warrant, Selectman Cullett second, 2-0

Item 10: Discussion and possible vote on repair to the Peru Fire Engine: Fire Chief Pelkey mentioned that he had emailed the Selectboard with Freightliner's estimate and they is still waiting on the parts to fix the brakes. The Selectboard reviewed the estimate from Freightliner. Fire Chief denied saying the truck goes through brakes often because the brakes were never changed before. It was noted that the truck shakes due to mismatched tires and rubber chunks missing on the tires. Also, the frame being twisted-Fire Chief mentioned that the frame was not twisted- just bolts missing. Selectman Cullett asked Fire Chief Pelkey what he thought about the estimate. Fire Chief Pelkey wants to bring the truck back to the Fire House after the brakes are fixed. Fire Chief Pelkey will then power wash the fire engine, tighten all bolts and fix the damaged mud flaps. Fire Chief Pelkey will hold off on the oil leak and the power steering leak until he gets more clarification on these issues. Fire Chief Pelkey is more concerned about the tires being worn out, chunks missing and feels the 4 rear tires should be replaced. Selectman Cullett instructed Chief Pelkey that once the brakes are fixed, he wants the truck brought back to the fire house and then bring the truck for an inspection sticker. Some discussion regarding the best oil to use for the oil change and Highway Superintendent Russell asked if synthetic oil is recommended for the Detroit engine in the fire truck. The Selectboard agreed that once the truck is back at the fire house most of the minor issues can be fixed in house. Fire Chief Pelkey is anticipating the brakes will be fixed by Friday, March 24<sup>th</sup>. Selectman Leach requested that Fire Chief Pelkey keep the Selectboard informed on any progress.

Item 11: Discussion on Open Meeting Law Complaint made by Kimberly Wetherell regarding Feb.9 and March 1

<u>Finance Meeting:</u> Selectman Leach motion to recess at 7:29 p.m. Selectman Cullett second, 2-0. Selectman Leach called the meeting to order at 7:33 p.m., Selectman Cullett present, Selectman Haskins present joined the meeting at 7:33 p.m. Selectman Leach present.

Selectman Cullett read alleged violation for 2/9/2023 and 3/1/2023 from Kimberly Wetherell which was received on March 10, 2023. The alleged violation was not dated or signed by Kimberly Wetherell.

The alleged violations were as follows:

- Outside of a public posted meeting, all members of the Peru Selectboard (Leach, Cullett, Haskins) attended the posted Finance Committee Meetings on 2/9/2023 and on 3/1/2023.
- As a quorum, the Selectboard engaged in conversation, interacted, commented and provided opinions to the Finance Committee regarding FY2024 budget, an impermissible deliberation outside of a posted meeting.
- The Selectboard is fully aware that a quorum of a public body on any public business warrants the posting of an agenda. Attending the Finance Committee's meeting and neglecting the posting of an agenda was an intentional violation of the Open Meeting Law.

Kimberly Wetherell is requesting the Selectboard take the following action:

Selectboard to review the open meeting law in an open meeting listed as a topic on their agenda focusing on the
OML's Guidance on the definition of a deliberation and a quorum. Selectboard to assure that the public is
properly notified of all meeting they anticipate attending regardless of purpose.

<u>Selectman Cullett read response to Kimberly Wetherell's OML violations.</u> Selectman Leach motion to accept letter of response pending changes, Selectman Cullett second, 3-0

The response to Kimberly Wetherell dated March 20, 2023, is as follows:

- We are in receipt of the OML complaint you forwarded March 10, 2023. In this complaint you allege that the Peru Selectboard violated the Open Meeting Law (OML) at the Peru Finance Committee meetings on February 9, 2023, and March 1, 2023. Please note that the complaint you forwarded by email on March 10, 2023, is not dated and is not signed (see enclosed).
- The Peru Board of Selectmen disagree with the allegations that you have outlined in your complaint. We offer the following facts to demonstrate that your allegations are unfounded, and the Peru Board of Selectmen did not violate the OML as you have asserted during the Peru Finance Committee meetings referenced in your complaint (February 9, 2023, and March 1, 2023:
- The letter contained 9 items denying alleged violations.
- In closing, we vigorously deny the allegations of any violation of the OML during the two Finance Committee meetings you outlined for the reasons outlined above. We consider your OML complaint dated March 10, 2023, to lack any merit and consider the matter closed.

Item 12: Discussion of FY24 Budget: The Highway Superintendent submitted his budget. The Board of Selectmen and Finance Committee will meet on Thursday 3/30/2023 to discuss budget. Highway only one. A brief discussion regarding temporary summer help and wages being raised to \$16.00. Selectman Haskins had questions about the budget then they will decide on the per hour increases. Superintendent Russell plans to reach out to the high school for summer help. For budgeting reasons, the Selectboard mentioned that they need to contact the Accountant for the balance remaining in ARPA funds.



# Highway Department Budget Request for FY24

1. Please see attached Interoffice Memorandum for list of Highway Dept accounts.

Please note the increase in Superintendent Salary and Highway wages.

I'm asking for in increase in the Superintendent Salary based on our neighboring town hiring a first year superintendent with a salary of \$75,000 with absolutely no highway department experience. In just under 8 years, I have managed over 2 million dollars in very successful road repairs and reconstruction, and I have helped secure the upcoming project on Route 143 that is estimated to cost 2.8 million dollars.

The wage account increase is to properly fund the salary increase of the 2 highway employees that had raises midyear.

Without these increases we are at a very high risk of losing our incredible highway department employees to other Municipalities or MASSDOT that are paying much higher salaries.

2. Purchase 1 New Plow for 2019 International.

See attached quote for the upgrade of 1 new 11' high plow from Zwack Inc. I'm waiting for more quotes.

3. Salt Shed Door Repairs

See attached quotes.

1st quote from Northeast Fabricators, to repair the rotted steel on the bottom of the doors.

2<sup>nd</sup> quote is from BETNR, to repair the rotted steel and install new corrugated steel over the doors after we remove the old wood off the face of the door.

My recommendation is to go with BETNR's quote for a permanent repair.

4. Replacement of Excavator Tracks and Drive Sprockets

Dear Ms. Wetherell:

We are in receipt of the OML Complaint you forwarded March 10, 2023. In this complaint you allege that the Peru Selectboard violated the Open Meeting Law (OML) at the Peru Finance Committee meetings on February 9, 2023 and March 1, 2023. Please note that the complaint you forwarded by email on March 10, 2023 is not dated and is not signed (see enclosed).

The Peru Board of Selectmen disagree with the allegations that you have outlined in your complaint. We offer the following facts to demonstrate that your allegations are unfounded and that Peru Board of Selectmen did not violate the OML as you have asserted during the Peru Finance Committee meetings referenced in your complaint (February 9, 2023 and March 1, 2023):

- Doug Haskins is an elected member of the Peru Board of Selectmen as well as an
  elected member of the Peru Finance Committee. Mr. Haskins attended each
  meeting you referenced as a member of the Finance Committee.
- 2. Bruce Cullett is an elected member of the Peru Board of Selectmen and serves as the Peru Police Department's Chief of Police and Emergency Management Director.
- 3. Verne Leach is an elected member of the Peru Board of Selectmen and serves as Peru's Animal Control Officer/Animal Inspector.
- 4. The OML allows members of a public body to attend meetings of another public body provided that they communicate only by open participation and that no deliberation occurs. No deliberation by the Peru Board of Selectmen occurred at either Peru Finance Committee meeting outlined in your complaint.
- 5. You were present for the February 9, 2023 Finance Committee meeting and will recall that Bruce Cullett attended that meeting representing the Peru Police Department and answered some questions from Finance Committee members regarding the potential purchase of a new police cruiser utilizing ARPA funds.

- This was one of the first items taken up by the Finance Committee during that meeting, and following completion of a vote taken by the Finance Committee supporting the purchase of the new cruiser Chief Cullett left the meeting to attend to other business.
- 6. You were present and recorded the March 1, 2023 Finance Committee meeting. Chief Cullett also attended the meeting and presented his FY 24 proposed budget to the Peru Finance Committee. He prefaced his budget presentation by indicating that he was attending the meeting as Police Chief and the purpose of his attendance was to present his proposed budget.
- 7. During the Finance Committee meeting on March 1, 2023 there were a number of issues discussed by the Finance Committee. On at least one occasion during the meeting Bruce Cullett stated that because the meeting was not posted as a Selectboard meeting he was not offering his opinions related to the items being discussed and the BOS could not deliberate. Mr. Cullett asked a handful of questions of Fire Chief/Finance Committee Member Jesse Pelkey while Chief Pelkey was presenting some information during the meeting but did not offer opinions on the subject matter.
- 8. During the meeting on March 1, 2023 Verne Leach in his role as Animal Control Officer (ACO) spoke to the Finance Committee and was asked questions by the Committee Chair about his proposed FY 24 budget including questions regarding salary and a potential vehicle for the ACO.
- 9. Members of the audience including yourself asked specific questions during the March 1<sup>st</sup> meeting several which were posed directly to Bruce Cullett. This included a question regarding the Peru Library Budget. Mr. Cullett provided you a copy of the Peru Library's proposed budget that was provided to the BOS during their meeting February 27, 2023. He also provided you with some historical context for the way the Town formulates the Peru Library Budget. If you review the audio recording you made of the meeting you will note that the answers provided were public knowledge, factual and were not opinions of an individual Selectboard member.

In closing, we vigorously deny the allegation of any violation of the OML during the two Finance Committee meetings you outlined for the reasons outlined above. We consider your OML complaint dated March 10, 2023 to lack any merit and consider this matter closed.
