BCAC Government Fuel Assistance Program

Fuel Assistance, also known as the Low Income Home Energy Assistance Program (LIHEAP), is a federally funded program to help low-income households with their heating bills. The program begins November 1st and ends April 30th each year. All heating types may be eligible for assistance: oil, propane, kerosene, coal, cord wood, wood pellets, natural gas, electric and even some households that have heat included in their rent.

Any low-income household whose gross yearly income falls at or below the income guidelines may be eligible. Homeowners and tenants are both eligible to receive fuel assistance. LIHEAP eligibility is evaluated based on your gross household income for the past 4 weeks.

Don't wait to apply for income-eligible assistance programs. Visit the BCAC online customer portal. <u>This website portal helps you assess your possible eligibility</u> for the Massachusetts Home Energy Assistance Program (commonly called Fuel Assistance) and submit the online application. New Law on Motor Vehicle Inspection Stickers

The Massachusetts Registry of Motor Vehicles is announcing, effective November 1, 2022, motor vehicles passing the required inspections *will get a new sticker with the month that their last sticker expired*, valid for one year. Any vehicle owner late in getting a vehicle inspected, beyond one year from the last inspection, will no longer get a sticker displaying the month the new inspection occurred.

The penalty for driving vehicles with an expired sticker, or driving an uninspected vehicle, may result in a moving violation and lead to additional fines, etc. In addition, vehicle owners will no longer receive a printed inspection report when a vehicle passes inspection.

Important Questions to Ask your Doctor about a Dementia Diagnosis

Maybe you suspected this was coming, or it could be a total surprise to hear the doctor say 'you have dementia'. It is a hard diagnosis to hear. You may not be able to absorb much information immediately after hearing the diagnosis. Below is a list of questions that other people living with dementia have found helpful. These questions are a good place to start. If possible, bring someone you trust with you to your appointments. You may also want to record what the doctor tells you.

- What is causing the dementia? Can it be reversed? It can be helpful to know the type of dementia you have to know what to expect. There may be reversible causes
- Explain to me more about the tests used to make the diagnosis and the results. It is ok to ask for more details. Especially about the various tests that looked at your individual cognitive abilities and disabilities.
- What can I expect from my specific type of dementia? Will it get worse? Knowing as much as you can about any medical diagnosis can help you plan for how you and your family will learn to accept and cope with your diagnosis.
- ➤ What treatments or medications are available? Only a handful of medications have been approved to treat Alzheimer's disease; they are often prescribed to treat other types of dementia as well. Ask your physician if any might work for you, as well as what side effects might develop.
- ➤ Can I/Should I still work & drive? Many people living with dementia can continue to work and may also be able to continue driving. Based on the cognitive test results the doctor may place some limits on these activities

Mattresses and Clothing Banned from Landfills

The Massachusetts Department of Environmental Protection has added textiles and mattresses to its disposal ban effective Nov. 1st. They will no longer be allowed in landfills. The ultimate goal is to reduce the amount of waste deposited in the constantly shrinking space still available in landfills, according to DEP officials.

John Fischer, DEP deputy division director for solid waste, said that "95 percent of textiles recovered can be reused. Used clothing, footwear and other household textile products such as sheets, towels, curtains, pillows and stuffed animals can be reused or recycled." According to waste composition analyses, approximately 230,000 tons of usable clothing, footwear, linens and other textile products are thrown away in Massachusetts annually. Goodwill, Salvation Army and homeless shelters will be happy to accept donations. The First Congregational Church on Maple Street, Hinsdale also has a donation box. Mattresses can be disposed of at Dalton recycling center for a fee.
