**Article 29:** To See if the Town will vote to transfer from Free Cash the sum of Fifteen Thousand Dollars and No Cents (\$15,000.00) for the Re-build of the Highway Department Boom Mower Deck and Replacement of Safety Glass or to take any other action relative thereto.

**Article 30:** To see if the Town will vote to transfer from Free Cash the sum of Seven Thousand Five Hundred Dollars and No Cents (\$7,500.00) for the cost of Police Education associated with the Commonwealth of Massachusetts Police Reform Legislation or take any other action relative thereto.

**Article 31:** To see if the Town will vote to transfer from Free Cash the sum of Five Thousand Dollars and No Cents (\$5,000.00) for the purchase of Five AED Units and associated equipment for use at the Town Hall and Community Center, Public Safety Vehicles, and the Highway Garage or take any other action relative thereto.

**Article 32:** To see if the Town will vote to transfer from Free Cash the sum of Ten Thousand Dollars and No Cents (\$10,000.00) for the Reserve Fund or take any other action relative thereto.

**Article 33:** Tow see if the Town will vote to approve the future purchase of a SUV Command Vehicle for the Fire Department not to exceed Nine Thousand Five Hundred Dollars and No Cents (\$9,500.00) out of the Future Equipment and Vehicle Expense Account.

**Article 34:** To see if the Town will vote to appropriate from Chapter 90 funds that are, or may become, available to the Town during the FY23 for Roadway Projects and Repairs, and to authorize the Treasurer to borrow such amounts in anticipation of reimbursement by the Commonwealth or take any other action relative thereto.

**Article 35:** To see if the Town will vote to authorize the Board of Selectmen, or other Town Departments with the approval of the Board of Selectmen, to apply for and accept grants from the Federal Government, Commonwealth of Massachusetts or any other source, and to expend the same for purposes received without further appropriation, or to take any other action relative thereto.

**Article 36:** To see if the Town will vote to authorize the Treasurer, with the approval of the Board of Selectmen, to borrow money from time to time in anticipation of revenue of the financial year beginning July 1, 2022, in accordance with the provisions of Massachusetts General Laws Chapter 44, Section 4, and to issue a note or notes therefore, payable within one year, and to renew any note or notes as may be given for a period of less than one year, in accordance with the General Laws Chapter 44, Section 17, or take any other action relative thereto.
